In consideration of my child's participation in the Cowdeo, I hereby release, waive, discharge and covenant not to sue Jefferson County, the Jefferson County Fair Complex, the Jefferson County Fair Board and their heirs, assigns, employees, officers, agents from all liability for any and all claims, demands, losses, damages or actions that may subsequently be brought by Participant or by any other persons on the account of any injury, death or property damage whether caused by the negligence of the above named parties or otherwise arising out of or connected with participation in the Cowdeo.

I assume liability for any injury or damage to any livestock or equipment caused by Participant while participating in the Cowdeo. I further agree to obtain and have in force adequate health insurance for Participant to cover any injury suffered by Participant while participating in the Cowdeo.

Participant and Parent acknowledge that helmets are mandatory for rough stock events and are available in the chutes. Participant and Parent agree that the above named parties are not responsible for the condition or quality of the helmets provided. Participants are strongly encouraged to wear helmets while participating in all Cowdeo events.

Participant agrees to carefully follow all instructions and orders of the event organizers and to provide parental consent prior to being allowed to participate.

Participant and Parent agree that this form shall be received as a defense to any action or proceeding that may be brought or commenced against any of the above named parties, and shall forever be a complete bar to the commencement or prosecution of any action or proceeding whatsoever on account of any injuries or damages that may be suffered as a result of being present at or participating in the Cowdeo. Participant and Parent further agree that if any portion of this form is held invalid, the balance shall continue in full force and effect.
